Pacific Ry. with said West boundary of public road, said point being 100 ft. from the center line of the main tract of said Ry. measured at right angles thereto and being 25 ft. from the center of public road. Thence in a westerly course along the North boundary line of right of way 100 ft. from center line of said Ry. 169 ft. to a stake, thence north 18 deg. west 652 feet to a stake. Thence North 72 deg. east 160 feet to a stake on the west boundary line of said public road. Thence South 18 deg. East 707 ft. to the point of beginning. 
